Pursuant to Notification No. 057-BOPEE of 2022 dated 16-09-2022, the Board notified the provisional merit list of candidates who had applied for admission to B-Pharmacy Course, 2022 where in the candidates were advised to submit their objections/deficient documents physically at BOPEE office Srinagar/Jammu upto 21-09-2022. In response to this, the Board has not received any objections in this regard.

It is hereby notified for the information of all the concerned eligible candidates who figure in the Provisional Merit List from Rank 01 to 500 that they are advised to report at BOPEE office Srinagar/Jammu as per following schedule between 8.30 am to 10.00 am for Registration and attendance for participation in the physical round of counseling:-

Further, keeping in view the limited number of seats available in Government/Private Institutions it has been decided to call candidates upto the Rank 500 for counselling in the first instance. The rest of the candidates figuring in the PML shall be considered for counselling subsequently in case the Board receives additional seats, if any, or the seats received as shortfall from the concerned Institutions due to non-joining of candidates and fill up the same in second round of counseling, if any, conducted by the Board.

Note:-

- I. The candidates are advised to bring along their all certificates/documents including Domicile certificate issued by the competent authority, 12<sup>th</sup> Class

Marks Card, Category Certificate including TFW on the day/date of counseling for presenting the same at the time of counseling.

- II. The Board reserves the right to notify any change(s) as may become necessary in view of any technical or any other difficulty / reason beyond its control.
- III. The eligibility criteria shall remain the same as notified by the Board in its various notifications issued from time to time on the subject.
- IV. The seat Matrix shall be uploaded separately on the website of the Board in due course of time before counseling.
- V. The reservation policy/rules shall be applicable in Government Institutions only.
- VI. Rank wise sports list for the said course has been Annexed as Annexure-A to this Notification.

The other terms and conditions shall remain the same as notified in e-information brochure, notifications and notices issued by the Board from time to time in this regard.

This issues without prejudice to the outcome of writ petition(s), if any, pending on the subject before any competent court of law.

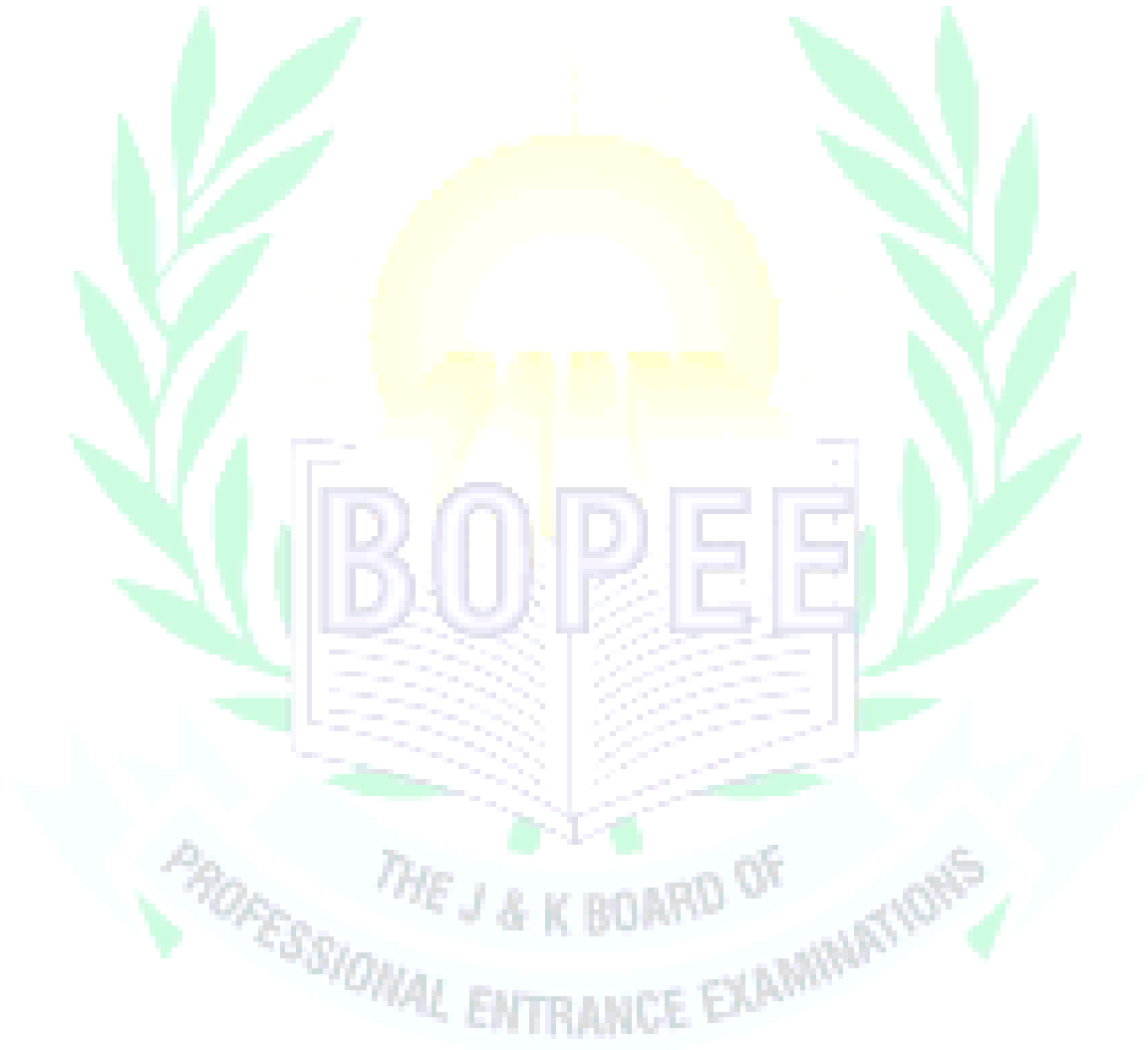
