## Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees)

 Act, 2007.No.GY-35-MCG-1018-SFS-23-J:- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 3 of 2008), the Government of Gujarat, hereby makes the following rules further to amend the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate courses) Rules, 2017, Namely: -

1. (1) These rules may be called the Gujarat Professional Medical Educational Courses [Regulation of Admission in Undergraduate Courses here specify the Sr . No. of amendment if it is not first for the year, 2022 (Amendment) Rules. 2022.
(2) They shall come into force on and from date of its publication in the Official Gazette.
2. In the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate courses) Rules, 2017 (hereinafter referred to as "the said rules"),
in rule 3, in sub-rule (1), in Para B under the heading Management Seats, for item(i) the following item shall be substituted, namely: -
" (i) Twenty-five per cent seats of the total sanctioned seats including fifteen percent Non Resident Indian seats of the Professional Medical Courses in the unaided Colleges, Institutions or a University.

Provided that management seats including Fifteen percent Non- Resident Indian seats in BHMS course shall be filled by consortium;

Provided that any management seat remains vacant, such seat shall be filled in as the available Government seats as provided in sub-rule (2) of rule 5."
3. In the said rules, in rule 4, in sub-rule(3), after the existing provisos, the following proviso shall be add, namely:-
"Provided further that for the purpose of admission only, the candidates who have taken admission before $233^{\text {rd }}$ June, 2017 in $10^{\text {th }}$ standards and passed $10^{\text {th }}$ standard from the school located outside of the state of Gujarat shall also be eligible."
4. In the said rules, in rule 5 , for sub-rule ( 1 A ), the following sub-rule shall be substituted, namely: -
"After deduction of the All India Quota, remaining available Management Quota excluding NRI Quota Seats and Government Quota seats shall be reserved for the candidate of Gujarat origin.";
5. In the said rules, in rule 4 for sub-rule (5), the following sub-rule shall be substituted, namely: -
"(5) No candidate shall be admitted in the Professional Medical Educational Courses in Government Seats, Management Seats and NRI seats unless he possesses minimum qualifying standard in HSC examination and NEET of current academic year, as may be determined by the respective council / the Central Government and fulfills other eligibility criteria under these rules.

## Minimum qualifying standard for Professional Medical Educational Courses:

Eligibility criteria in HSC examination and NEET of current academic year.
(a) For Government seats: -

6. In the said rules in rule 7,-
(1) In sub-rule (i), the following proviso shall be substituted, namely: -
"Provided that management seats including NRI seats in BHMS course shall be filled by the Consortium";
(2) In sub-rule (iv), the following provisos shall be substituted, namely: -
"Provided that management seat including NRI seats in BHMS course shall be filled by the Consortium. The Consortium shall, by an advertisement in two English and two Gujarati leading newspapers widely circulated in the State, invite an application from the eligible candidates for the admissions to the BHMS Course on the management seats. The advertisement shall contain the date of issue of application forms, centers from where the application forms may be obtained and to where submitted, last date for submission of application forms, details of fees to be paid and eligibility criteria and numbers of seats available for admission on the management seats and such other information as may be necessary in this behalf.

The Consortium shall also make necessary arrangements to issue and receive the application forms for admission to the Management seats at the office of the Admission Committee at the GMERS Medical College, Gandhinagar.

All the management seats shall be filled in by the Consortium by a Single Window System on the basis of merit list prepared on the basis of All India Overall rank of the candidates and whose names appear in the merit list prepared by the Admission Committee.

Provided further that no candidate shall be admitted against the management seats unless his name appears in the merit list prepared by the Admission Committee.

Provided also that where any Non-Resident Indian seat remains vacant, such seat shall be converted into management seats and filled in from the merit list of management seats.";
(3) In sub-rule (v), the following shall be inserted at the end, namely: -
"Any other conditions regarding admission, laid down by Govt. of India /MCI/ National Medical commission shall be applicable".
7. In the said rules, in rule 11, in sub rule (1), for the item (viii), the following item shall be substituted, namely:-
"(viii) In case, where considerable number of seats fall vacant, and it appears to the Admission Committee to fill the vacant seats, it may conduct the admission process for readjustment (reshuffling). The candidate can reshuffle seats/choice options during the process of readjustment (reshuffling). In such readjustment (reshuffling) of seats, the candidate who opts to participate in reshuffling process, shall be considered for such admission. The candidate may either give option for upgradation of choices already given or submit new choices. The candidates shall not be offered admission on the seats available to him in previous allotment process. If the candidate gets admission on the basis of upgradation or new choice, then his earlier admission shall be treated as cancelled.
(a) The candidates holding a seat in Round 1 and/ or Round 2 of State Counselling are not allowed to take part in Mop-up round of AIQ counselling as per the Government of India Notification No.MCI-34(41)/2018-Med./109835, dated the $18^{\text {th }}$ May, 2018.
(b) In case, where number of seats fall vacant after completion of first online round, it appears for the Admission Committee to fill the vacant seats, they may conduct subsequent online rounds (second OR third) of counselling, in such online counselling, the upgradation of seats which is done. i.e., Reserved category to open.

Where again number of seats fall vacant after completion of online round, it appears for the Admission Committee to fill the vacant seats, they may conduct offline counselling, in such counselling, the upgradation of seats which is done in online counselling, shall not be followed for existing admitted students. i.e., Reserved category to open.
(c) In any circumstances if the Admission Committee carries out offline counselling, then if a candidate takes admission in particular category in offline counselling i.e., PwD, NRI, SC, ST,

SEBC, EWS then he shall not be eligible for admission in the general category in said counselling at his turn."
8. In the said rules, in rule 15 , in sub-rule (3) for clause (b),the following clause shall be substituted, namely: -
"(b) In case of a candidate withdrawing his candidature after completion of entire admission process by admission committee, for any reason whatsoever, he may request in writing to the college or institution in which he is granted admission and cancellation shall be done by the college or institution. In such case the fee shall be refunded, by such college or institution."
9. In the said rules, for rule 16 , the following shall be substituted, namely: -
"16. After the completion of the admission process and exhaustion of merit list of the eligible candidates as per admission rules, if government seats and management seats in the MBBS, BDS, BAMS, BHMS remain vacant or vacancy arise due to any circumstances, such vacant seats shall be filled up from candidates who have applied to the Admission Committee and qualify as per NEET-UG criteria but not included in the merit list of the committee because of not fulfilling the other criteria of Admission Rules. After completion of that process, if any seats are still remain vacant, such vacant seats shall be displayed on the official website and on the notice board of the office of the Admission Committee and the same shall be intimated to the colleges or institutions wherein the seats are vacant and the institution shall filled up the seats as per the criteria laid down by the respective council / Central Government / NMC/MCI for respective year from merit list of NEET-UG of current year by non-admitted students only."
10. In the said rules, for the words "Medical Council of India" wherever it occurs, the words "National Medical Commission"/ "MCI" shall be substituted.
