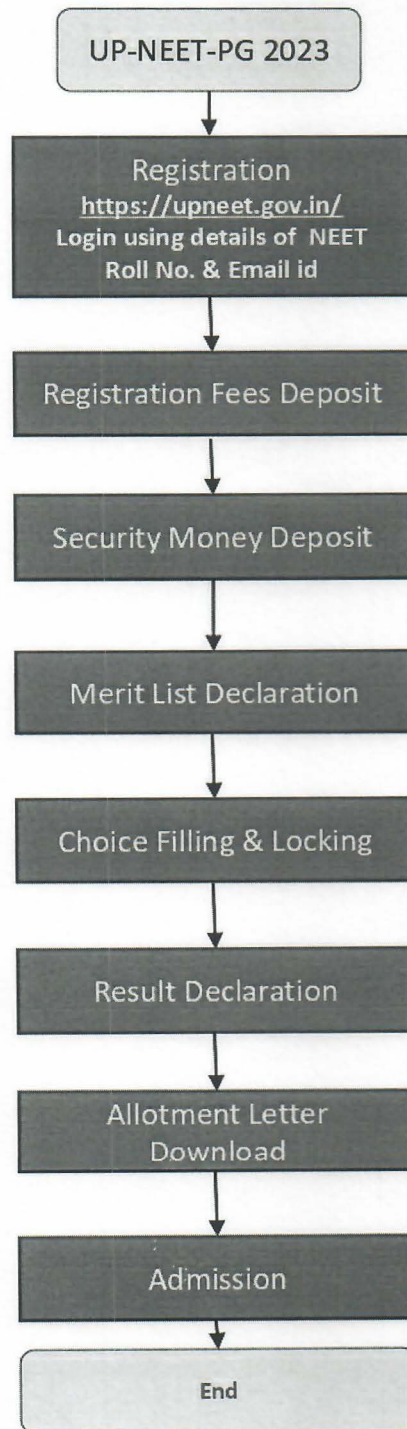

Chapter-2: Eligibility

- Candidates who have qualified NEET-PG-2023/NEET-MDS-2023 entrance examination.
- Candidates who have completed their one year of Compulsory Rotatory Internship on or before by **30st June 2023** for MDS and **11th August, 2023** for MD/MS /Diploma/DNB courses.
- Candidates who have passed MBBS/BDS course from the Govt/Private Medical & Dental Colleges of U.P. are eligible for Government State Quota seats and Private Medical College seats.
- Candidates who have passed MBBS/BDS from AMU, Aligarh & BHU, Varanasi are *not* eligible for admission in Government State Quota Seats. Such candidates are eligible for admission only in Private Medical & Dental Colleges.
- Candidates who have passed MBBS/BDS from *outside of Uttar Pradesh* are eligible for admissions only in Private Medical & Dental Colleges/Institutes/Universities.

- A candidate who has already taken admission on the basis of earlier NEET- PG/ NEET- MDS is not eligible for the NEET PG-2023/ NEET-MDS-2023 counseling until he/she completes and passes the course where he/she is presently admitted.
- However, such a candidate shall be eligible if he/she has resigned from the said course and his/her resignation has been accepted by the competent authority of the Medical & Dental College/Institutes/Universities and he/she has refunded the salary/stipend received by him/her during the said course along with the fulfillment of the terms and conditions laid down in the format of the Bond of Rs. 5 Lacs at the time of admission.
- Only those NEET qualified PMHS candidates, whose list is provided by Director General Medical & Health under policy framed by Health & Family Welfare Department, are eligible for due weightage as per norms, will be eligible for UP NEET PG-2023 counselling.
- Foreign Medical Graduates (FMG) & Foreign National Candidates are eligible for UP NEET PG-2023 counselling as per eligibility criteria mention in NBE Information Bulletin-2023-point no. **4.10 & 4.11.** (**Annexure- 5**) (Read with Notice Dated 07.02.2023 N.B.E. New Delhi)
- Only **In-service** candidates are eligible for state quota DNB seats.

Chapter-3: Reservation

- Reservation will be given as per directions of Government of Uttar Pradesh vide **Govt. Order No.- I/348793/2023, Dated-13-07-2023**. [Link](#)
- Reservation Policy of the State Government for the NEET PG-2023 counselling in Govt State Quota seats is as follows:

Vertical Reservation:

- ❖ S.C.-21%
- ❖ S.T.-2%
- ❖ O.B.C - 27%
- ❖ EWS- 10%

Horizontal Reservation:

- ❖ PwD- 5%
- The list of SC/ST/OBC categories shall be as notified by the Government of Uttar Pradesh as applicable at the time of counselling. (**Annexure- 3**)
- Reservation of seats under PwD Category is 5% in Government State Quota Seats and the 21 Benchmark Disabilities as envisaged under the regulations of Rights of Persons with Disabilities Act 2016 and as per the NMC norms.
- Candidates who want to avail 5% PwD reservation in PG seats of Govt. medical institutions should obtain Disability certificate as per 21 Benchmark Disabilities given under RPWD Act 2016 and as per NMC norms, from the designated disability centres as per the list enclosed as **Annexure- 2**.
- The certificate issued by any other hospital/ board will not be accepted.
- There will be no reservation for candidate in Private Medical/Dental colleges.
- There will be reservation for minority in Minority Medical/ Dental Colleges according to their bylaws.

- Candidates admitted through 15% quota seats of AIQ in M.B.B.S./BDS course in Government Medical Colleges will not be given the benefit of reservation in PG course for state quota seats and they will be considered as unreserved category.
- All certificates related to reservation will be valid only on the format prescribed by the Government of Uttar Pradesh and issued by the competent authority
- For EWS and OBC category, certificates issued only after April 01, 2023 will be valid.
- Apart from Uttar Pradesh, the reserved category candidates of other states will be considered in the unreserved category.
- For other relevant points regarding reservation candidates should advice to see **Govt. Order No.- I/348793/2023, Dated-13-07-2023**. [Link](#)

Chapter-4: Registration Process

- Only online registration will be permissible on website <https://upneet.govt.in>.
- For registration, candidate will use his/her NEET-PG Roll No. & same email ID used by them during registration on NBE website for NEET PG-2023/ NEET MDS-2023 entrance examination and follow instructions on website.
- Candidate's data at the time of registration on NBE portal will be pre-populated and will be used for counselling purposes.
- Thereafter Registration form will be displayed, candidates have to enter only his/her domicile, category, sub category, In-service (PMHS) employment status and MBBS passed from, address etc.
- Candidate will make payment of Registration fee of Rs. 3,000/- for 1st & 2nd round of counselling.
- All eligible candidate requires fresh registration for Mop-up & Stray vacancy round separately with Registration fee of Rs. 2,000/-
- Registration fee is non-refundable.
- After successful submission of registration form, registration number will be generated.
- During Registration process candidates will create a Password for choice filling and locking of the choices.
- Once the registration process is successfully completed candidates will generate Registration form & Registration fee slip.
- Candidates are advised to download their Registration form & Registration fee slip.











- Registration form & Registration fee slip *will have to be shown at Medical college/Nodal center at the time of admission.*

Security Fee:

1. For Govt. Medical & Dental Colleges/Institutes/ Universities- Rs. 30,000/- [Thirty Thousand]
 2. For Pvt. Medical Colleges/Institutes/ Universities- Rs. 2,00,000/- [Two Lakhs]
 3. For Pvt. Dental Colleges/Institutes/ Universities- Rs.1,00,000/- [One Lakh]
- If security fee is not submitted by candidate, then he/she will not be permitted for choice filling.
 - After successful payment download security money receipt for future reference.
 - Receipt of security money will have to be shown at the medical college/Nodal center at the time of admission.

Chapter-5: Counselling Process

- Merit list for MD/MS/Diploma candidates will be prepared after providing weightage to In-Service (PMHS) candidates as per the provisions of Govt. Order No.I/348793/2023, Dated-13-07-2023. [Link](#)
- It is advised that before choice filling candidates independently gather information about Private colleges in which he/she wish to take admission.

Online Choice filling:

- For choice filing visit website <https://upneet.gov.in> and login by using NEET Roll number and Password created at the time of registration.
- You can change your choice until the final locking.
- Choice filing will not complete till candidates finally submit and lock their choices within scheduled time.
- Choice Locking is compulsory, if not locked then online allotment will not occur.
- No changes will be permissible after locking the choice.

Seat Allotment:

- After scheduled period of choice filing, seat allotment will be done on merit cum option basis.
- Seat allotment status of successful candidates will be displayed on website <https://upneet.gov.in>.
- Selected candidates download allotment letter for reporting at allotted Medical College/ Designated Nodal Centre.

- If Candidate does not take admission after first round of counselling allotment, then security money will be forfeited. For participation in second round of counselling security money will have to deposited again.
- If Candidate has taken admission after first round of counselling in the allotted college but wants to reshuffle his/her seat/college, then he/she will remain eligible for second round of counselling and can fill the choices for second round.
- It is advised that candidates do not opt same seat/college in which he/she was already admitted.
- If he/she is allotted any other seat or same seat again, then previous allotment will be automatically get cancelled.
- It is mandatory to take admission in the new allotted seat, if he/she does not take admission in the new (re-shuffled) seat, the new allotment will get cancelled.

MOP-UP Round:

- Candidates who are allotted but not joined/admitted/ resigned any seat will not be eligible for MOP-UP Round.
- Any candidate who has taken admission in any PG course in any Medical & Dental College in India through All India/ other state counselling will not be eligible for MOP-UP Round.
- Fresh registration with Rs 2000/- is mandatory for Mop-Up round and only these candidates will be included in the mop-up merit list.
- Candidates will have to produce certificates in original at the time of admission.
- The conversion of seat will be carried out during the Mop-up round of seat allotment for State quota. The said conversion will be done only when the



candidates belonging to the said conversion category have exhausted. The algorithm for conversion of category is as follow:

- As per the orders of Hon'ble Supreme court of India in I.A. No.132614/2022 in WP (C) 267/2017, counselling for stray vacancy round shall be conducted online.
- Fresh registration will be done during stray vacancy round.

Chapter-6: Admission Process

- Candidates have to complete their admission Process including fees deposition at allotted Medical & Dental Colleges/ Nodal center mentioned in allotment letter. (**Annexure- 1**)
- It will be mandatory for the candidates allotted seats in Private Medical & Dental College/Institute/University (except minority Institutions) to deposit the tuition fee fixed by the government at the time of admission. In minority Colleges/Institutions, it will be mandatory for the candidates to deposit the tuition fee prescribed by the respective Colleges/Institutes.
- If candidate does not take admission to the allotted seat by the due date, he/she shall forfeit any right of admission on the basis of said counseling/allotment.
- Candidates who fail to produce required original documents at the time of admission or if any concealment or falsification of facts comes to the light at the time of admission or thereafter during the academic sessions, it will make the candidate lose his/her candidature and he/she would be subjected to legal action.
- Bond will be made to the effect that in-case student leaves the Government Medical/Dental College seat after the 2nd counseling, or at any time during the course of study, then the candidate will deposit an amount of Rs 5,00,000/- (Five lakhs) as per Govt. Bond.
- Following documents in original and one set self-attested photocopy will be deposited for admission:
 1. Copy of Allotment letter
 2. Admit Card of NEET PG-2023/ NEET MDS-2023
 3. Registration slip and Security Fees slip
 4. High School Marksheet and Certificate (as proof of date of birth)
 5. Intermediate Marksheet and Certificate
 6. Mark sheets of all professional examinations



7. MBBS/BDS passing out certificate or degree
8. Compulsory Rotatory Internship completion certificate
9. Permanent Registration Certificate (State Medical council /MCI/DCI)
10. Employers NOC certificate, if employed
11. Reservation certificate (SC/ST/OBC/EWS/PwD certificate), if applicable.

Chapter-7: Resignation

- Resignation will only be acceptable as per directions of Government of Uttar Pradesh vide **Govt. Order No. I/348793/2023, Dated-13-07-2023.** [Link](#)
- The candidates who have joined a seat in 2nd round of State quota counselling or AIQ counselling will not be eligible for the further rounds of counselling. Vide order dated 31/03/2022 the Hon'ble Supreme Court of India in W.P. No. 174 of 2022 issued directions which are as follows:

“In line with the regulations which have been notified on 5 April 2018, students who have joined in round 2 of the state quota or round 2 of the AIQ shall not be eligible to participate in the mop-up round for All India Quota.”

- The Hon'ble Supreme Court of India vide Order dated 09/05/2017 passed in Writ Petition (C) No.267 of 2017 –Dar-Us-Slam Educational Trust & Ors Vs MCI & Ors. Directorate General of health Services, Ministry of Health & Family Welfare had directed as follows:

“After the second round of counselling for All India Quota seats, the students who take admission in All India Quota seats should not be allowed/permitted to vacate the seats. This would ensure that very few seats are reverted to the State Quota and also All India Quota seats are filled by students from the all-India merit list only. The students who take admission and secure admission in Deemed Universities pursuant to the second round of counselling conducted by the DGHS shall not be eligible to participate in any other counselling.”

- Provision given in the Government Order No. I/348793/2023, Dated-13-07-2023 regarding the resignation are as follow: [Link](#)

- यदि कोई अभ्यर्थी प्रथम काउंसिलिंग से आवंटित होकर प्रदेश के किसी भी राजकीय/ निजी क्षेत्र की मेडिकल/डेंटल की सीट पर प्रवेश प्राप्त कर लेता है तत्पश्चात वह प्रदेश की प्रथम काउंसिलिंग से प्रवेशित सीट से त्यागपत्र देना चाहता है तो ऐसे अभ्यर्थी द्वितीय काउंसिलिंग की च्वाइस फिलिंग से दो दिन पूर्व (उदाहरणार्थ यदि द्वितीय काउंसिलिंग की च्वाइस फिलिंग 24 अगस्त 2023 से प्रारम्भ है, तो अभ्यर्थी 21 अगस्त 2023 को सायं 04.00 बजे तक) अपनी सीट से त्यागपत्र दे सकता है। ऐसी स्थिति में अभ्यर्थी द्वारा जमा की गयी धरोहर धनराशि जब्त कर ली जायेगी।

Chapter-8: Service Bond

- Those taking admission in Govt colleges will have to mandatory serve in the state of UP as per rules and serve a bond to this effect.
- According to the Government Order No. 950/71-2-82/2017 Dated 07.03.2018 as amended Dated 23.08.2022, candidates taking admission in postgraduate courses will be processed in respect of the agreement bonds related to compulsory government service:
