## INTRODUCTION

The Arunachal Pradesh State Council for Technical Education (APSCTE), an autonomous body under the Directorate of Higher and Technical Education, Government of Arunachal Pradesh will conduct the Online Counselling for nomination in the various Degree courses (PCB group) against the seats made available to the State by the Govt. of Arunachal Pradesh and other Regional bodies. The selection of candidates shall be on the basis of Rank in the NEET 2023 conducted by NTA.

### ELIGIBILITY:

1. The children of Arunachal Pradesh Scheduled Tribe (APST), children of Non-APST employees of the State Government, All India Services (AIS), the Central Government & the Central Public Sector Undertakings serving in Arunachal Pradesh and all the others residing in Arunachal Pradesh for the last 3 years or more and who have passed Class XII from any of the schools within Arunachal Pradesh and who have appeared the NEET 2023.

For admission to MBBS, BHMS, BAMS, BUMS & BDS candidate should have obtained marks above CUTOFF declared along with the result of NEET 2023.

2. The minimum academic qualifications and age to be eligible for counselling and admission in the various courses will be as follows:

- i) FOR DEGREE COURSES: - Passed Class XII (with at least 40% marks) from a Govt. recognized Board with Physics, Chemistry and Biology.

The minimum age for admission in the various courses will be 17 years as on 31<sup>st</sup> Dec' 2023.

The age limits for admission will further be governed by the norms of the Medical Council of India and other respective affiliating bodies or the admitting institutions.

### PERSONS WITH DISABILITIES:

The status of candidates claiming for Persons with Disabilities (PwD) quota will be verified on the basis of the declaration made at the time of filling up of the forms for NEET 2023. Further, the candidate claiming for PwD quota will have to submit relevant Certificate issued by a duly constituted Medical Board. **Such candidate(s) will also have to undergo further medical examination before 1<sup>st</sup> round of seat allotment and should be prepared for the same at a Short Notice. Prevalent Norms prescribed by Medical Counseling Committee, Govt of India for MBBS admission shall be applicable for all the courses.**

**Above all**, such PwD candidates should be capable of undergoing the course with his/her condition.

**CATEGORIES OF CANDIDATES:**

On fulfilling the eligibility as mentioned above, the candidates shall be placed in the following 2(Two) categories depending on the criteria as mentioned against each:

a) CATEGORY-I (APST)	All the APST candidates which also include children of AIS/Central Govt./State Govt. employees belonging to APST
b) CATEGORY-II (Non-APST)	<ul style="list-style-type: none"> <li>i. Children of Non-APST State Government employees.</li> <li>ii. Children of employees of All India Services/ Central Government organizations &amp; Central Public Sector Undertakings serving within the territory of Arunachal Pradesh</li> <li>iii. All others, not included in any of the above categories with the condition that the candidate should have passed Class XII or equivalent from any of the schools within Arunachal Pradesh and his/her parent(s) should have been residing in Arunachal Pradesh for atleast the last 3(three) years. Both the criteria should be fulfilled.</li> </ul>

**REGISTRATION FEE**

The interested candidates desirous of taking part in the Online Counseling has to pay one time Non-refundable registration fee as under at the time of initial registration:-

**DISTRIBUTION OF SEATS:**

The distribution of seats will be as per the Reservation Policy of the State for admission to technical / professional institutions as has been notified and / or amended from time to time.

As per the Reservation Policy of the State Govt. the distribution of the seats amongst the various categories as mentioned above will be as follows:

**Allotment Procedure****Registration and Choice filling :**

- All eligible candidates will register Online on **www.apdhte.nic.in** as per the schedule and remit the notified Registration Fees.
- During online registration, candidates are required to provide/verify information viz. name, Gender, age, State of Domicile, Category, PwD Status, marks of Class XII or equivalent examination etc.
- The candidates will also have to upload relevant documents viz, Category Certificate, Class X certificate, Class XII marksheet, NEET 2023 Rank Card, Photograph, PwD certificate, etc. These will be verified ONLINE.
- All candidates who are found eligible after document verification will be able to fill, change, reorder and delete their choices of courses/institutes as per their preference as per notified schedule. Candidates are advised to LOCK their choices after they are satisfied with their Choice Filling. However, once locked, candidates will not be able to unlock or change the choices.
- FILLING OF CHOICES FOR THE ONLINE COUNSELLING WILL BE ALLOWED ONLY ONCE DURING THE SCHEDULED PERIOD. THEREFORE, CANDIDATES ARE ADVISED TO FILL THEIR CHOICES IN THIS PERIOD WITHOUT FAIL TO BE CONSIDERED FOR SEAT ALLOTMENT IN BOTH THE ROUNDS.
- Candidates can fill as many choices as they desire.

- If a candidate fails to explicitly lock his/her choices by the stipulated time, his/her last saved choices will be automatically locked after this deadline. Candidates are therefore strongly advised to lock their choices themselves. Candidates **MUST TAKE PRINTOUT** of their locked choices for future references.
- A registered candidate, who have not filled any choice and/or has failed to save them even once during the choice filling, will not be considered for seat allotment.
- If the information submitted by any candidate is found to be fraudulent, incorrect or untrue, the seat allotted (if any) is liable to be cancelled. Moreover, such candidates will no longer be considered eligible for admission and will also be liable for legal action.

#### **Seat Allotment and reporting to the Directorate / Institutes for Round 1.**

- Seats for the first round will be allotted to the candidates in order of the choices they have filled during online choice filling, on the basis of their merit as per NEET 2023 and availability of seats in their respective categories/Institutes/courses.
  - The first round of seat allotment will be notified and displayed on [www.apdhte.nic.in](http://www.apdhte.nic.in). Candidates can also view the seat allotted to him/her after logging into their individual accounts.
  - Candidates, after the declaration of result of 1<sup>st</sup> round of counseling will have to perform the following after logging into their account:
    - ✓ View Seat Allotment
    - ✓ Print the Provisional Allotment Letter
    - ✓ Pay the Security Deposit/Seat Acceptance Fee ONLINE
    - ✓ Submit Willingness ONLINE as detailed below:
      - **Floating Option:** This option is to be chosen if the candidate accepts the seat allotted in the present round but wants to be considered for all of his/her higher preference choices during the subsequent round (second round) of seat allotment.
- OR
- **Freezing Option:** This option is to be chosen if the candidate is satisfied with the seat allotment and wants to accept the institute and course allotted to him/her without waiting for the 2<sup>nd</sup> round.
  - All the candidates who have got an allotment for medical related courses like MBBS, BDS, BAMS, BUMS, BHMS, B.Sc (RIT/OOT/MLT/Nursing), B. Pharma etc., have opted for **Freezing Option**, and have paid the Security Deposit /



Seat Acceptance fees as detailed above, will report to the Directorate of Medical Education, Research and Training, A Sector, Naharlagun within the stipulated date, along with all relevant documents, the Seat Allotment Letter downloaded from the portal with details of payment of Security Deposit / Seat Acceptance fees. The nomination letter will be issued by the Directorate of Medical Education, Research and Training after verifying all details of the candidate.

- Candidates allotted non-medical courses like B.V. Sc & AH, B.Sc (Agri/Horti/Forestry/Fishery/Community Sc/Nutrition & Dietetics/Seri) , have opted for **Freezing Option**, and have paid the Security Deposit / Seat Acceptance fees as detailed above, will report to the Directorate of Higher and Technical Education, ESS Sector, Itanagar within the stipulated date, along with all relevant documents, the Seat Allotment Letter downloaded from the portal with details of payment of Security Deposit / Seat Acceptance fees. The nomination letter will be issued by the Directorate of Higher and Technical Education, after verifying all details of the candidate.
- If a candidate fails to choose **Float or Freeze** option for the seat allotted in the 1<sup>st</sup> round **OR** fails to remit the Security Deposit / Seat Acceptance fees or fails to report to the respective Directorate within the stipulated date, the seat allotment shall stand cancelled and he/she will not be considered for seat allotment during the second round.
- Candidates who have opted for **Floating Option** in the first round **AND** have paid the Seat Acceptance Fee / Security Deposit fee will **ONLY** be considered for seat allotment in the second round.
- Candidates who have been allotted a seat in the 1<sup>st</sup> round but neither opts for **Floating or Freezing option** shall be treated as not interested and such candidates will not be allowed in the 2<sup>nd</sup> round. However, they may participate in the Spot round, if held.
- Candidates are therefore advised to at least choose the FLOATING OPTION and pay the Seat Acceptance Fees/Security Deposit if they are to be considered for upgradation in the 2<sup>nd</sup> Round.
- Candidates **opting for Floating** after the 1<sup>st</sup> Round allotment will retain the seat allotted if no seats of higher preference are allotted in the 2<sup>nd</sup> Round. However if such candidates are allotted seat of their higher preference choices during second round, they will forfeit their claim on seats allotted to them in first round, and allotment of first round shall automatically stand cancelled.

### **Seat Allotment and reporting to the Directorate / Institutes for Round 2.**

- Only the seats which remain vacant after the completion of reporting for the 1<sup>st</sup> Round will be available for allotment in the 2<sup>nd</sup> Round to the candidates who have opted for Floating Option for the 1<sup>st</sup> Round and to those candidates who have not been allotted any seat in the 1<sup>st</sup> Round.
- The second round of allotment done on the basis of the available seats and on the basis of the merit of NEET 2023 will be notified and published in the website [www.apdhte.nic.in](http://www.apdhte.nic.in).
- Candidates, after the declaration of result of 2<sup>nd</sup> round of counseling will have the **Freeze** option only under **Submit Willingness tab**.
  1. A Candidate whose seat has been either upgraded or retained during the second Round will have to Freeze the allotment and report to the respective Directorates as has been described for the First Round for issue of Nomination Letter during the notified schedule.
  2. A candidate who has been allotted a seat only in the 2<sup>nd</sup> round will view and download the provisional allotment letter, pay the Seat Acceptance Fee /Security Deposit, Freeze the willingness and report to the respective Directorate as has been described for the 1<sup>st</sup> round.
  3. If the candidate fails to pay the Seat Acceptance Fee / Security Deposit, Freeze the allotment or report to the respective Directorate within the stipulated schedule, the seat allotment shall stand automatically cancelled. Such seat shall be automatically available for the Spot Round.

### **Withdrawal of Seats**

- Candidates who have been issued provisional admission / nomination letter during the 1<sup>st</sup> or 2<sup>nd</sup> round but had not taken admission in the allotted Institution and want to withdraw the seat can do the same ONLINE within the stipulated schedule. Such candidates can participate in the Spot round if they so desire.
- Candidates who have taken admission in the allotted Institution will not be allowed to withdraw the seat.
- Seat Acceptance Fee/ Security Deposit of candidates who have withdrawn their seat during the stipulated period will be refunded as and when notified by the Directorate.

### **Spot Round**

- A Spot round may be conducted after the second round to fill the remaining vacant seats, if any or if any additional seats are received after the start of the process of Counselling
- The following candidates will be eligible for participation in the Spot round:
  1. Candidates who have withdrawn their allotted seat within the stipulated time.
  2. Candidates who have not been allotted any seat up to second round.
  3. Fresh candidates who could not register before the first round. Such candidates will have to register Online and pay the requisite registration fees.
- However, those candidates who have a confirm seat allotted and have not withdrawn their seat, cannot participate in the spot round. Candidates who have taken admission in an Institution against an allotted seat will not be permitted to join the Spot round.

### **Reporting at Allotted Institute.**

- Candidate, who opts for **Freezing Option**, should report to the respective Directorate, collect the Nomination letter and report to the allotted institution for admission as per its admission schedule.
- Allotment to candidates who have been offered seats but do not report at the allotted Institute within the scheduled period shall stand automatically cancelled and such seats shall be allotted to other candidates.

### **Other information**

- Candidates should themselves ensure that the personal information provided by them is genuine and authentic.
- Candidates should not disclose/share their password with anybody. They must understand that they are solely responsible for safe guarding their passwords.
- Candidates should be aware of the fee structure of the institutes where they are interested to take admission. The fee structure of different participating institute may be different. For details about the infrastructure, hostel facility, fees, placement record etc., candidates are advised to contact the respective institute or to visit their website.
- Moreover, if a student reports and joins at the allotted Institute and makes the payment of fees etc. but subsequently quits the college, the fee etc. deposited at the Institute may or may not be refunded by the Institute.

- Candidates may take a printout (hard copy) of the registration form containing the above personal data. It is solely the responsibility of the candidates to verify that their personal data, including category, subcategory, state of eligibility, gender etc. are consistent with documentary evidence.

#### **Payment and Refund of Security Deposit**

In order to avoid unnecessary blockages of seats till the last date of admission by some of the candidates thereby causing loss of seats, security deposit as detailed shall be levied :

The amount shall be forfeited if the candidate do not take admission within the due date of admission.

The Security Deposit / Seat acceptance fee shall be refunded to the candidates who completes the admission in the allotted institute or withdraws his seat during the window period provided for the purpose. For refund of the Seat Acceptance Fee/Security Deposit, candidates will have to submit documents like admission receipt etc. or proof of withdrawal of seat, as and when notified by this Directorate.

#### **DOCUMENTS REQUIRED FOR REGISTRATION AND ADMISSION:**

Candidates are advised to keep the following documents, (in original along with 03 (Three) sets of self attested photocopies) for submission whenever asked for:

1. Pass port size photograph
2. Class X pass certificate for verification of age
3. Class XII marksheet/ pass certificate.
4. NEET 2023 Score Card
5. PWD certificate (if applicable)
6. Security Deposit / Seat acceptance fee receipt.
7. School Leaving/ Transfer Certificate
8. Migration Certificate
9. Medical Fitness Certificate
10. Certificate to ascertain the category of the candidate i.e.
  - i. APST Certificate for Cat.-I
  - ii. Employment Certificate from respective employers or Domicile Certificate issued during 2023 by First Class Magistrate during 2023 for Cat.-II.

### Conversion Rules:

Before allotment of seats in the first round, if the number of registered eligible PWD candidates is less than the seat available, conversion of PWD seats to non PWD is possible within the categories i.e. Cat I PWD to Cat I and Cat II PWD to Cat II separately to the extent of availability of PWD candidates.

If there is any resultant vacancy in the seats reserved for the PWD candidates after the first round of counselling, such seats will be converted to non PWD seats within the separate Categories for the second and subsequent round(s).
