NOTE :

- 1) Candidates should ascertain their eligibility for each round as per the Information Brochure of NEET UG 2024.
- 2) The Filling of Status Retention form is choice of the candidate. However, Status retention form once filled cannot be taken back. Hence, candidates should be careful about filling the status retention form.
- 3) Candidates of CAP-1, if fail to resign before 25/09/2024 will be considered as part of CAP-2 and rules will apply accordingly.
- 4) **Resignation after 23/10/2024 will lead to Penalty as per Clause 16. of the Information brochure.**

➤ **Regarding Eligibility of CAP-3 round of MBBS/BDS courses.**

1) As per the Information Brochure 11.4.4 the following candidate not be eligible for CAP-3 Round

- Candidates who have joined seat up to Round 2 and filled Status Retention Form
- Candidates who have joined seat in Round 1, Round 2 and /or allotted a seat in Round 3 of All India Quota seats.
- Also as per Information Brochure Clause 7.1
“If the admission gets cancelled due to any reason upto Round 2, e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the admission authorities at the time of reporting or fails to produce the required documents at the time of admission. will have to register again as per schedule to be able to participate in Round 3 “
