<u>KEAM 2024</u> <u>ADMISSION TO AYURVEDA (BAMS), HOMOEOPATHY</u> (BHMS), SIDDHA (BSMS) & UNANI (BUMS) COURSES, <u>KERALA-2024</u>

APPLICATION SUBMISSION FACILITY RE-OPENED FOR STRAY VACANCY ROUND-3

The facility to submit fresh online applications for admission to Ayurveda (BAMS), Homoeopathy (BHMS), Siddha (BSMS) & Unani (BUMS) Courses for the academic year 2024-25 has been re-opened prior to stray vacancy round 3 as per NCISM/NCH directives dated 22.08.2024. Qualified candidates who have **not yet registered** their online applications can avail this facility up to **01.12.2024**, **11.59 PM** through the website **www.cee.kerala.gov.in** as per the conditions mentioned in the notification No CEE/152/2024-TA1 dated 26.03.2024 and Ref.No: NCISM/Examinations/ State DME/2024 dated 12/11/2024, F/No.3-5/ 2024 /NCH/ HEB/ AyushUGAdmsn2024-25/6017-6028 dated 11/11/2024.

The Stray Vacancy allotment will be conducted to fill up the **currently available vacant seats** after Second Round of Stray Vacancy Allotment and vacancies arising, if any. The net vacant seats after Second Round Stray Vacancy Allotment will be published. The fresh applicants, who find a place in the rank list, can participate in the third round stray vacancy filling allotment, subject to the condition that none of the allotments/admissions carried out in the previous allotments are disturbed.

The candidates who have not submitted applications to the Commissioner for Entrance Examinations for admission to Professional Degree Courses through KEAM-2024 must register through the link **'KEAM 2024-Online Application'** provided in the website www.cee.kerala.gov.in. On clicking the link, the candidate will be directed to a web page containing the online application. After completing the 5 steps for submission of the online application illustrated in clause 7.4 of the Prospectus for KEAM 2024, candidate should download the Application Acknowledgement Page and keep a copy of it for future reference. Candidates need not send the printout of the Acknowledgement page or other documents to the office of the Commissioner for Entrance Examinations.

Important:

- 1. Candidates who have already submitted applications to the Commissioner for Entrance examinations under KEAM 2024 as per the earlier Notifications **should not submit fresh applications**. <u>Multiple</u> <u>applications will lead to the cancellation of candidature as per the</u> <u>KEAM 2024 prospectus conditions</u>.
- 2. Fresh applicants who wish to be considered for admission to various reservation category seats or for any income based fee concessions, should submit, along with the online application, the required supporting documents (Community Certificate, Non Creamy Layer Certificate for State education purpose, EWS certificate, income certificate, etc., as the case may be) to substantiate the claims for reservation or fee concession. There will be no opportunity to submit supporting documents later under any circumstances. The reservation claims will be considered only against the reservation categories available after the second round of Stray Vacancy Allotment.

All candidates are requested to go through the eligibility conditions, academic qualifications, documents required etc., in the Notification dated

26.03.2024 and 15.11.2024. Also requested to read the Government approved Prospectus for admission to Engineering, Architecture, Pharmacy, Medical & Medical Allied courses available in the website **www.cee.kerala.gov.in** before the submission of fresh application.
