Notification for exercising web options for 2nd Phase of web-based counseling for admission into **BAMS & BHMS** Courses under **Management Quota** and **All India Quota** Seats in Private Un-aided Non-Minority BAMS & BHMS colleges under Dr. NTR UHS for the academic year 2024-25.

In continuation of earlier notification dated 21.10.2024, 07.11.2024 & 16.11.2024 the University hereby notifies the **2nd Phase** of web-based counselling for **BAMS & BHMS Courses** available under Management Quota and All India Quota seats in Private Un-aided Non-Minority, BHMS/BAMS colleges (under Dr. NTR UHS) for the academic year 2024-25 in the state of Andhra Pradesh.

All the eligible candidates who are in the Merit list notified in the website on **05.12.2024** only eligible to exercise their options as per the seat matrix displayed on the website <https://drntr.uhsap.in>

Allotment Process:

- Eligibility criteria for both AIQ & MQ Seats are similar and all seats are in open in nature and there is no requirement for any domicile certificate. The seat allocation will be done as per the directions issued by the Ministry of AYUSH, New Delhi, Lr. No. NCISM/COE/Neet-UG/2024, dt.22-08-2024.**
- AIQ Seats will be filled first based on web options by order of merit from the Merit List.**
- Important Note:** - NCISM, New Delhi, Ministry of Ayush has notified that, there shall not be any offline admission or admission without counselling (Central/State/UT) and any admissions in contravention of this shall not be approved. Hence, all admissions under Management will be conducted by Dr. NTR UHS, Vijayawada only.

UNIVERSITY FEE: Candidates to whom allotment message is given have to pay **Rs.20,100/-** for **Management Quota** and **Rs.8,600/-** for **All India Quota** before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

TUITION FEE FOR BAMS & BHMS COURSES: The selected candidates have to pay tuition fee per year for admission into **MQ & AIQ** seats in Private **BAMS & BHMS** Courses in Un-aided, Non-Minority Ayurvedic & Homoeopathy Colleges as per orders of the following Government of Andhra Pradesh G.Os.

Instructions regarding web options and allotment of seat:

1. Eligible candidates should exercise web options from the available seats in all Private Un-aided Non-Minority Ayurvedic & Homoeopathy Medical colleges in the State of A.P.
2. **Candidates whose names are found in the Final list of In-eligible candidates for AACCC/State/UT AYUSH UG counselling 2024-25 notified by AACCC, New Delhi, Vide Ref. No. AA-11013/1/2024-EP-I, dt. 17.10.2024, 02.11.2024, 12.11.2024 & 29.11.2024 are not eligible to participate under this notification.**
3. The following are the vacancies available for **MQ** Phase-II:

5. Options once exercised are final, and no scope for change of options or order of priorities will be entertained after closure of web options schedule.
6. Candidates are instructed to pay utmost care, while exercising options on the web.
7. No further notification for exercising web options will be issued.
8. Based on the merit list and order of priority of colleges, allotment letters will be released to the candidates, if seat is allotted.
9. The candidate who secured admission in the Phase-I of counselling and wish to change their college/course according to their merit, can exercise their web options. Candidates informed that once BAMS & BHMS seat is allotted in this phase of counselling as per their web options, the seat allotted in the Phase-I of counselling is automatically cancelled and Re-allotted to other candidates in this Phase-II.
10. Candidates while giving options should note the seats vacated by the candidates selected in previous counselling and slide to other college/course during this phase of counselling process will be added & allotted simultaneously during the phase of counselling itself.

11. Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the **website** for **MQ**: <https://apuhs-ugadmissions.aptonline.in/UGAYUSHMQ/Home/studentlogin> and for **AIQ website**: <https://apuhs-ugadmissions.aptonline.in/UGAYUSHAIQ/Home/StudentLogin> for status of allotment.
12. Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II, but should download the allotment order if there is a change in Phase-II.
13. Principals are requested to ensure that an allotted candidate can report at any one college/course either in CQ or MQ in case the candidate gets seat in both CQ & AIQ or MQ of Phase- II counselling. The Principals are requested to honour the decision of the candidate in choosing the allotted seat of admission. There shall not be any dual reporting of any candidate in CQ & AIQ or MQ at different/same colleges.
14. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
15. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
16. Candidates are informed that verification of original certificates will be conducted at the college which admission was confirmed and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.

Information regarding Phase-III

17. Phase III of counselling will be conducted with fresh options for the available seats after completion of Phase-II counselling.
18. **If not allotted any seat in Phase-II:** Candidates who have not been allotted any seat in the Phase-II of counselling will be considered for available vacancies in Phase-III of counselling with fresh Options.
19. **If not reported at the allotted college:** The candidates who do not report at the allotted college in the Phase-II counselling, will be allowed to participate in the Phase-III counselling with fresh options, provided that the candidates have no right to claim earlier Phase-II allotted seat again under Phase-III counselling.
20. If the joined candidates of Phase-II slides to other college during Phase-III of counselling, the Original Certificates of such candidates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order along with Custodian Certificate issued by the previous college under Dr. NTR UHS and to pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.
21. Candidates getting upgraded in Phase-III of Counselling will not have any claim on previous allotments, i.e., Phase-II seat as the vacancies resulting from upgradation

are filled within this phase by the next candidate in the merit list with rules of reservation as applicable.

22. There is no upgradation after Phase-III of counselling.

23. **The University fee once paid shall not be refunded under any circumstances.**
