**The requisite fees of a Tripura state domicile OBC(Non creamy layer) candidates will be as like requisite fees of general category candidate.*

Mandatory security deposit is a must for all intending participating candidates (Round-1 and Round-2 registered candidates) for participating in Round-2 counselling. If mandatory security deposit is not paid and not uploading/submitted the originals of transaction details in schedule time shall not be considered for allotment for any seat in Round-2 Counselling of Tripura State NEET PG 2024 Counselling.

The Mandatory Security deposit is refundable if not forfeited by specific events.

- **Round-1 Registered candidates** shall have to login and upload documents of submission of security deposit in their profile to participate in the Round-2.
- **For Freshly Registered Candidates:** Fresh **registration fees** will be applicable to participate in Round 2 which shall have to be deposited through online mode and also **mandatory Security deposit** as notified earlier, which is mandatory for all to participate in Round-2 counselling. Documents of Eligibility, NEET PG 2024 Score Card and all others relevant certificates shall have to be uploaded during Online Registration.



The mandatory security deposit shall have to be submitted through bank demand draft/Bank deposit/online transaction. The demand draft shall have to be payable in favour of “**Directorate of Medical Education, Government of Tripura**” from any nationalized bank Preferably SBI.

All the candidates are requested to submit the original demand draft/counterfoil of original bank deposit/scanned copy of online transaction receipt mentioning the transaction number/ID to the office of the Director of Medical Education, Bidurkarta Chowmohani, Agartala on or before 13-12-2024, 12 Noon.

A scanned copy of original bank deposit/demand draft/online transaction has to be **mandatory** uploaded online during application for Round-2 online Counselling.

Allotment of a seat shall **NOT to be considered** if the uploading of scanned copy of original transaction details of security deposit is not uploaded during online registration and original demand draft/counterfoil of original bank deposit/scanned copy of online transaction is not submitted at the office of the DME within the stipulated time as stated.

Instruction to the Candidates participating in Round-2 of Tripura State NEET PG Counselling

1) All the candidates are requested to go through the information bulletin, Schedule, seat matrix, flow chart and earlier notifications issued by the Director of Medical education, Govt. of Tripura in respect to Tripura NEET PG 2024 Counselling to keep abreast of the counselling.

2) All the aspirant eligible candidates are also instructed to follow the DME website <https://dme.tripura.gov.in> at frequent intervals for further Notices/Updates/Notification which may be issued from time to time.

3) Candidates are instructed to participate in the “Choice filling” as per their fresh choices in the Counselling link: <https://dmeonline.tripura.gov.in> for allotment of seats as per seat matrix and category according to Merit.

Round-1 choices shall be treated as null and void.



4) Candidates are instructed to follow the website of allotted Institutions for details regarding admission and other details.

5) Once a candidate freshly allotted or upgraded a seat in Round-2, previous admitted seat in Round-1 (if any) shall automatically get cancelled.

6) Candidate shall have the option of upgradation to the Round 3 to get eligibility for Round-3 after getting **admitted** to a Round-2 allotted seat.

7) A Candidate allotted a Round-2 seat but **NOT admitted** to the Round-2 seat can participate to Round-3 with **“forfeiture of Security Deposit”**. Application for such opted “forfeiture by a Candidate” to go to Round-3 shall have to be email from their registered email ID to the DME (**directormetripura@gmail.com**) mentioning all details of NEET result and Registered Phone Number and email ID with supportive documents on or before 28-12-2024 by 5pm.

The application of such “forfeiture” shall have to also be submitted offline by a candidate to the Director of Medical Education, Bidurkarta Chowmohani, Agartala on or before 28-12-2024 by 5pm.

8) In case of **surrender of a seat**, a candidate has to apply to the **admitting Institution** to get the **relieving certificate** from the admitting Institution accordingly and then a copy of the relieving certificate issued by the admitting Institution shall have to be submitted by the candidate to Director of Medical Education, Government of Tripura. A copy of the relieving certificate has to be sent also through email (**directormetripura@gmail.com**) to DME from the Registered email address of the candidate.
