In continuation of earlier notification dated 16.10.2024 the University hereby notify the Phase-II/Final web-based counselling for admission into PG AYUSH (i.e., MD (Homoeo) & MD/MS (Ayurveda) courses for the academic year 2024-25 in the colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada in the state of Andhra Pradesh.

All the eligible candidates who are present in the Merit lists notified in the website on **28.11.2024** are only eligible to exercise their options as per the seat matrix displayed on the website <u>https://drntr.uhsap.in</u>

The seat allocation will be done as per the Procedure given in G.O.Ms.No.603, HM & FW (R2) Dept., dt.23.12.2004 as amended in G.O.Ms.No.13, HM & FW(F2) Dept., dt.05.02.2021.

<u>UNIVERSITY FEE:</u> Candidates who are allotted with a seat, have to pay Rs.10,100/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

TUTION FEE: The selected candidates have to pay tuition fee and other constituent fee, special fee and caution money deposits at the rates laid down for the purpose from time to time subject to the conditions laid therein at the time of admission. The regulations governing the same will be informed.

Instructions to Candidates:

- The candidates who secured their AIQ-PG seats through Round-I, II & III of AACCC PG Counselling 2024 are not eligible to participate in this counselling as per Ref. L-14030/110/2022-EP-I, Dt.21.11.2024, 04.12.2024 & 09.12.2024. If it is found that the in-eligible candidate participated in this counselling, candidature of such candidate will be cancelled and will not be permitted in further counsellings.
- 2) Vacancy position is displayed on University website for the information of the students to exercise their options.
- 3) The following are the vacancies available for Competent Authority Quota Phase-II/Final Counselling

- 4) Fresh options will be obtained from all the eligible candidates for Phase-II/ Final Phase of counselling.
- 5) Reported Phase-I candidate can upgrade from Phase-I to Phase-II/Final Phase of Counselling Candidates getting upgraded in Phase-II shall not have any claim on Phase-I seat.
- 6) If a candidate is allotted a seat in MD(Homoeo) & MD/MS(Ayurveda) courses as per his/her options and does not join the course under the Competent Authority Quota Phase-I counselling he/she is eligible for Phase-II/Final counselling.
- 7) Phase-I seats vacated because of sliding to other colleges during the course of Phase-II/Final counselling will be added and allotted simultaneously to the next candidates as per the Merit and Rules
- 8) Candidate can exercise any number of options. The students have to opt clearly for the course in which they are desirous to join.
- 9) Conversions will be conducted in this Phase-II/Final Phase counseling for filling up of the unfilled vacancies if any as per the rules.
- 10) Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
- 11) Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II/Final, but should download the allotted order if there is a change in Phase-II/Final.

Mop-Up Round Counselling:

12) Counselling for Mop-Up Round will be done for the unfilled seats if any after Phase-II.

- 13) Candidates allotted seat in MD(Homoeo) & MD/MS(Ayurveda) courses as per his/her options under the Competent Authority Quota Phase-I or Phase-II/Final counselling are not eligible for Mop-up Round of counselling to prevent seat blocking.
- 14) As per G.O. Ms No.13, HM & FW (F2) Dept., dt. 05.02.2021, If any candidate wish to discontinue their course, after closure of the admission (or) during the course of period should pay of Rs. 50000/-+9000/-@18% GST (Rupees Fifty Nine thousand only) in the form of DD drawn in favour of the Registrar, Dr.NTR University of Health Sciences, A.P., Vijayawada.
- 15) The University fee once paid shall not be refunded under any circumstances.
