Notification for exercising web options for Phase-III of web-based counseling for admission into **BAMS & BHMS** Courses under **Management Quota** and **All India Quota** Seats in Private Un-aided Non-Minority BAMS & BHMS colleges under Dr. NTR UHS for the academic year 2024-25.

In continuation of earlier notification dated 05.11.2024 & 05.12.2024 the University hereby notifies the **Phase-III** of web-based counselling for **BAMS & BHMS Courses** available under Management Quota and All India Quota seats in Private Unaided Non-Minority, BHMS/BAMS colleges (under Dr. NTR UHS) for the academic year 2024-25 in the state of Andhra Pradesh.

All the eligible candidates who are in the Merit list notified in the website on **05.12.2024** (excluding the ineligible candidates as per Notice, dt. 11.12.2024) only eligible to exercise their options as per the seat matrix displayed on the **website** <a href="https://drntr.uhsap.in">https://drntr.uhsap.in</a>

### **Allotment Process:**

- a) Eligibility criteria for both AIQ & MQ Seats are similar and all seats are in open in nature and there is no requirement for any domicile certificate. The seat allocation will be done as per the directions issued by the Ministry of AYUSH, New Delhi, Lr. No. NCISM/COE/Neet-UG/2024, dt.22-08-2024.
- b) AIQ Seats will be filled first based on web options by order of merit from the Merit List.
- c) <u>Important Note:</u> NCISM, New Delhi, Ministry of Ayush has notified that, there shall not be any offline admission or admission without counselling (Central/State/UT) and any admissions in contravention of this shall not be approved. Hence, all admissions under Management will be conducted by Dr. NTR UHS, Vijayawada only.

**UNIVERSITY FEE:** Candidates to whom allotment message is given have to pay before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

## <u>Instructions regarding web options and allotment of seat:</u>

- 1. Eligible candidates should exercise web options from the available seats in all Private Un-aided Non-Minority Ayurvedic & Homoeopathy Medical colleges in the State of A.P.
- Candidates allotted seats in CQ/Phase-III will be eliminated before processing MQ/AIQ allotments though they exercised options. Therefore, candidates should take calculative decision in choosing options for CQ or AIQ/MQ.
- 3. Candidates whose names are found in the Final list of In-eligible candidates for AACCC/State/UT AYUSH UG counselling 2024-25 notified by AACCC, New Delhi, Vide Ref. No. AA-11013/1/2024-EP-I, dt. 17.10.2024, 02.11.2024, 12.11.2024, 29.11.2024 & 11.12.2024 are not eligible to participate under this notification.

- 6. Options once exercised are final, and no scope for change of options or order of priorities will be entertained after closure of web options schedule.
- 7. Candidates are instructed to pay utmost care, while exercising options on the web.
- 8. Candidates are further requested to opt for all the colleges irrespective of the vacancies available.
- 9. No further notification for exercising web options will be issued.
- 10. Based on the merit list and order of priority of colleges, allotment letters will be released to the candidates, if seat is allotted.

- 11. The candidate who secured admission in the Phase-I or Phase-II of counselling and wish to change their college/course according to their merit, can exercise their web options. Candidates informed that once BAMS & BHMS seat is allotted in this phase of counselling as per their web options, the seat allotted in the Phase-I or Phase-II of counselling is automatically cancelled and Re-allotted to other candidates in this Phase-III.
- 12. Candidates while giving options should note the seats vacated by the candidates selected in previous counselling and slide to other college/course during this phase of counselling process will be added & allotted simultaneously during the phase of counselling itself.
- 13. Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website for MQ: <a href="https://apuhs-ugadmissions.aptonline.in/UGAYUSHMQ/Home/studentlogin">https://apuhs-ugadmissions.aptonline.in/UGAYUSHAIQ/Home/StudentLogin</a> and for AIQ: <a href="https://apuhs-ugadmissions.aptonline.in/UGAYUSHAIQ/Home/StudentLogin">https://apuhs-ugadmissions.aptonline.in/UGAYUSHAIQ/Home/StudentLogin</a> for status of allotment.
- 14. Students who have already paid the University fee in Phase-I or Phase-II need not pay again if seat is allotted in Phase-III, but should download the allotment order if there is a change in Phase-III.
- 15. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
- 16. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
  - 17. Candidates are informed that verification of original certificates will be conducted at the college which admission was confirmed and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.

# Information regarding Mop-up

- 18. There is no upgradation after Phase-III of counselling.
- 19. Mop-up of counselling will be conducted with fresh options for the available seats after completion of Phase-III counselling.
- 20. **If not allotted any seat:** Candidates who have not been allotted any seat in any Phase of counselling will be considered for available vacancies in Mop-up Round of counselling with fresh Options.
- 21. Candidates not reported in Phase-I or Phase-II are eligible to Participate in Mopup Round of counselling.
- 22. Candidates reported in Phase-I or Phase-II are not eligible to Participate in Mopup Round of counselling.
- 23. Candidates allotted in Phase-III are not eligible to Participate in Mop-up Round of counselling.

# 24. The University fee once paid shall not be refunded under any circumstances.
