Notification for exercising web options for Phase-III of web-based counselling for admission into MD/MS (Ayurveda) under competent Authority Quota seats for the academic year 2024-25

- 1) On 15.12.2024, this University has received conditional permission for enhancement of seats from 31 to 36 in MD/MS (Ayurveda) course at S.V. Ayurvedic College, Tirupati for the Academic Year 2024-25
- 2) Through letter, dt.14-12-2024, the Principal, S.V. Ayurvedic College, Tirupati, has requested to fill the above seats in the State Counselling for the academic year 2024-25 referring the letter, dt.22-10-2024 of the NCISM, New Delhi wherein it was stated that permitted UG seats on or after 11.10.2024 and PG seats on or after 17.10.2024 shall be included in the respective State/UT counselling and the respective authorities are directed to include the newly added All India Quota Seats under Govt./Govt. aided colleges in the State/UT counselling for the A.Y.2024-25. This is only a one-time measure for this academic year only.
- 3) In view of the above, as the facility of upgradation in State Quota is only upto phase-II, the Competent Authority has decided to conduct Phase-III after adding 05 seats in MD/MS (Ayurveda) course at S.V. Ayurvedic College, Tirupati duly protecting the merit while giving upgradation as per the rules.
- 4) In continuation to the information notified dated 28.11.2024 & 10.12.2024, it is hereby informed that the Competent Authority has decided to conduct Phase-III counselling duly protecting the merit after adding 05 seats in MD/MS (Ayurveda) course at S.V. Ayurvedic College, Tirupati in adherence to the instructions issued by the NCISM, New Delhi vide their letter, dated 22.10.2024
- 5) In view of the above, all the eligible candidates present in the final merit position notified in the website on <u>28.11.2024</u>, are only eligible to exercise their options for this Phase-III of counselling as per the following schedule.

<u>UNIVERSITY FEE:</u> Candidates who are allotted with a seat, have to pay Rs.10,100/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

<u>TUTION FEE:</u> The selected candidates have to pay tuition fee and other constituent fee, special fee and caution money deposits at the rates laid down for the purpose from time to time subject to the conditions laid therein at the time of admission. The regulations governing the same will be informed.

Instructions to Candidates:

- I. The candidates who secured their AIQ-PG seats through Round-I, II & III of AACCC PG Counselling 2024 are not eligible to participate in this counselling as per Ref. L-14030/110/2022-EP-I, Dt.21.11.2024, 04.12.2024, 09.12.2024 & 11.12.2024 If it is found that the in-eligible candidate participated in this counselling, candidature of such candidate will be cancelled and will not be permitted in further counsellings.
- II. The following are the vacancies available for Competent Authority Quota Phase-III/Final Counselling

- III. Fresh options will be obtained from all the eligible candidates for Phase-III/ Final Phase of counselling.
- IV. Reported Phase-II candidate can upgrade from Phase-II to Phase-III/Final Phase of Counselling Candidates getting upgraded in Phase-III shall not have any claim on Phase-II seat.
- V. If a candidate is allotted a seat in MD/MS(Ayurveda) courses as per his/her options and does not join the course under the Competent Authority Quota Phase-II counselling he/she is eligible for Phase-III/Final counselling.
- VI. Phase-II seats vacated because of sliding to other colleges during the course of Phase-III/Final counselling will be added and allotted simultaneously to the next candidates as per the Merit and Rules
- VII. Candidate can exercise any number of options. The students have to opt clearly for the course in which they are desirous to join.
- VIII. Conversions will be conducted in this Phase-III/Final Phase counselling for filling up of the unfilled vacancies if any as per the rules.
- IX. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the



- allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
- X. Students who have already paid the University fee in Phase-II need not pay again if seat is allotted in Phase-III/Final, but should download the allotted order if there is a change in Phase-III/Final.

Mop-Up Round Counselling:

- XI. Counselling for Mop-Up Round will be done for the unfilled seats if any after Phase-III.
- XII. Candidates allotted seat in MD/MS(Ayurveda) courses as per his/her options under the Competent Authority Quota Phase-II or Phase-III/Final counselling are not eligible for Mop-up Round of counselling to prevent seat blocking.
- XIII. As per G.O. Ms No.13, HM & FW (F2) Dept., dt. 05.02.2021, If any candidate wish to discontinue their course, after closure of the admission (or) during the course of period should pay of Rs. 50000/-+9000/-@18% GST (Rupees Fifty Nine thousand only) in the form of DD drawn in favour of the Registrar, Dr.NTR University of Health Sciences, A.P., Vijayawada.
- XIV. The University fee once paid shall not be refunded under any circumstances.
