## ADMISSION INTO BHMS COURSE UNDER MANAGEMENTQUOTA (B & C) FOR 2024-25 NOTIFICATION FOR EXERCISING WEB OPTIONS FOR SPECIAL STRAY VACANCY PHASE

In continuation of earlier notifications dated 08-10-2024, 25-10-2024, 05-11-2024, 11-11-2024, 15-11-2024, 29-11-2024, 11-12-2024 and 16-12-2024, Kaloji Narayana Rao University of Health Sciences notifies the conduct of Special Stray Vacancy phase of webbased counseling for admissions into BHMS course under Management Quota (B & C category) in affiliated Private Homeo Colleges in the State of Telangana

Eligible candidates notified in the consolidated provisional final merit list for BHMS course under Management Quota for 2024-25 notified on the KNRUHS website on 29-11-2024 are directed to exercise web - options online from computer with internet connection from **8.00 AM on 17-12-2024 to 4.00 PM on 17-12-2024** through website <a href="https://tsbhmsmq.tsche.in">https://tsbhmsmq.tsche.in</a> subject to following conditions.

- Candidates who are included in the List of In-eligible candidates to participate in Central/State /UT/ Institutional/Central Pool Quota/ AIQ (Private Institute) Counseling, 2024 for admission to ASU & H UG-courses for the A.Y 2024-25, communicated by Ayush Admissions Central Counseling Committee (AACCC) are not permitted to exercise web options.
- 2. Candidates are admitted under KNRUHS for MBBS/BDS course under Competent Authority Quota and Management Quota are not permitted to exercise web options.
- 3. Candidates who are admitted under MCC Counselling as notified on MCC website are not eligible to exercise web-options.
- 4. Candidates who were allotted UG AYUSH seats in the previous phases of counseling under Management Quota are not eligible to exercise web-options.
- 5. Candidates are admitted under KNRUHS in UG AYUSH courses under Competent Authority Quota are not permitted to exercise web options.

## **IMPORTANT INSTRUCTIONS TO THE CANDIDATES:**

- 1) Vacant seats for Special Stray Vacancy phase of counselling are notified on KNRUHS website <a href="http://knruhs.telangana.gov.in">http://knruhs.telangana.gov.in</a> Eligible candidates as per provisional final merit list can exercise web options for vacant seats in all Private Homeo colleges as per their interest and priority through web-site <a href="https://tsbhmsmq.tsche.in">https://tsbhmsmq.tsche.in</a> from computer with internet facility. Do not use Tabs or Mobiles to exercise web-options.
- 2) Candidates are advised to go through the Prospectus available on KNRUHS website before exercising web-options.
- 3) Candidates have to exercise web-options for B category and for C (NRI) in order of priority for college and B or C category. Allotments will be made according to the order of preference in the web options exercised by the candidate.
- 4) Candidates are informed that they have to exercise web-options to the colleges in which they are interested to join. In case the candidate does not join the college after allotment, the allotment will be cancelled and penalty clause shall be applicable.
- 5) Important Note: candidates are informed that if they exercise web- options for a seat and allotted a seat as per their choice of web- options in this phase of counseling and if they do not join the course at the allotted college then he/she has to pay penalty of Rs. 1,00,000/- (one lakh) and also will be debarred for 3 years for UG AYUSH admission under KNRUHS if any to prevent seat blocking.

- 6) One time password will be sent to the registered mobile number at the time of exercising web-options. The password consists of SIX letter code with English capital A to Z. (For details read instructions to the candidates before giving options).
- 7) Candidates are instructed to take a print out of saved options for reference.
- 8) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on web-site <a href="https://tsbhmsmq.tsche.in">https://tsbhmsmq.tsche.in</a> after each phase of counseling without fail.
- 9) The selected candidate shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should take print out of allotment letter, check their allotment and report to Principal of allotted college.
- 10) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, bond, pay the tuition fee and college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically.
- 11) Candidates are hereby informed that final verification of original certificates will be conducted by the Admission Committee at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 12) Original certificates will not be returned to candidates unless the candidate discontinues from the course.
- 13) The University fee once paid shall not be refunded under any circumstances.
