In compliance to Hon'ble High Court Order dated 19.12.2024 in DB Special Writ Petition No. 1238/2024 and in continuation to **Notifications dated 23.09.2024, 30.10.2024, 16.11.2024 and all subsequent notifications** for MD/MS, Post MBBS DNB and Post MBBS Diploma courses in Rajasthan), schedule for the allotment process (Round 2) will be as below:

Schedule for Allotment process (Round 2)

<u>Application form</u> Start date for filling of on-line application form and deposition of required application fee It is a mandatory step for subsequent process of counseling and allotment. Both the parts (Part 1 and Part 2) of the application form must be filled and completed. <u>Those candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may now complete the same.</u> <u>Those who are already registered/have applied need not register/apply again.</u> <u>Important note: All concerned In-service candidates are specifically again informed that if they register now to participate in the State Counseling Process, then their candidature as in-service candidates will be considered without giving any incentive / bonus marks.</u>	22.12.2024

On-line choice filling locking of the choices by the candidates (including filling up and saving of the choices / changing the filled choices multiple times) Note: Choice filled by candidate in Round 1 will not be considered for Round 2 allotment. Following candidates, who wish to participate in Round 2, must fill choices: 1. Earlier registered candidates who did not get allotment in Round 1 OR got allotment in Round 1 but did not join or resigned after joining 2. Joined candidates of Round 1 who wish to upgrade 3. Newly registered candidates Note: Joined candidates of Round 1 who do not wish to upgrade and wish to retain their Round 1 seat need not fill choices in Round 2.	22.12.2024 to 27.12.2024 (11.45 pm) (choices auto-locked at 11.45 pm on 27.12.2024)

Verification, Allotment and Reporting by State NEET PG 2024 Registered Eligible Sr. Demonstrator candidates for In-Service Quota (sub quota), (before the Board, at 9.00 am at Academic Block, SMS Medical College, Jaipur) All such candidates must present themselves physically along with all original relevant documents only after depositing security amount. Reporting, document submission (including prescribed eligibility criteria) at the allotted college desk at Academic Block, SMS Medical College, Jaipur along with printout of allotment letter, all original documents, required bonds etc. and 2 copies of application form along with Self attested photocopies (one set) of all relevant documents as listed in information booklet Note: (i) Round 1 joined candidates who get upgraded shall bring fee receipt issued by Round 1 joined college (their original documents will be transferred directly to Round 2 upgraded college). (ii) Round 1 joined candidates who filled choices for upgradation but not upgraded to Round 2 (allotted same college in Round 2) need not report again for the same college. 1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. All fresh candidates are required to deposit non-refundable application fee of Rs. 4000/- (Rs. 3000/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.
3. **All PwD candidates** must present themselves physically for document verification before the admission board on **28.12.2024** as per the notification and the list to be made available at the website.
4. **All Eligible Senior Demonstrators** must present themselves physically with all applicable original documents for verification and allotment before the admission board on as per the notification.
5. The last date of Resignation for Round 1 joined candidates shall be **22.12.2024 by 2:00 pm**, after this date and time no resignation shall be allowed and rules will be applicable accordingly.
6. The candidates are advised to visit the websites regularly for registration and other relevant information.

Important:

For candidates willing to participate/upgrade in Round 2, it is mandatory to fill fresh choices in Round 2 (irrespective of whether the candidate was allotted/joined a seat in Round 1 or not).

The choices filled by candidate in Round 1 shall be scraped and will not be considered for Round 2. If a candidate does not fill fresh choices for Round 2, then he/she will not be considered for allotment/upgradation in Round 2.
